# Ka Pacitotācik Oki – Ka Pimikiskiyihtakik

Kānata kihci oyasowewin, ka pacitotākocik oki ka kostatikosiyit aweya (ewakonik oki ka kipahikāsocik neso ahpo mecet nawac askewin ekwa ekota ka ohci kitapamihcik Correctional Service of Canada (CSC) ka icikoātek ahpo Parole Board of Canada (PBC)) ka ki kacitinamwak oma kekwāy ka kiskinitakik anihi kicih ka ki pacitotākocik. Moya māka semāk ka kiskiyitākik – ka masinahikecik piko ote isi CSC ahpo PBC ekosānima ka isiyikatek ka masinahaman ki wihowin.

Anoekih ka kih sapopayik *Canadian Victims Bill of Rights* (CVBR) ekosi nawac ekwa mistahi mena petos towa kekwāy kih kiskiyihtenanaw oki ka ki pacitotācik ka ki kiskiyitākik. Ewako masinahikans meyawak oki ka kih pacitotācik kekwāy ka kih kiskiyitākik, mena anihi oskiyi ekota kāsteki CVBR, tānsi kawi isi kācitinamihk, tansoma ka kih totahkik CSC’s asici PBC’s koyasowihk, ekwa mena kotaka kekwāya ka kih isi wechikocik kihcokimāwin.

# **Ka kih kăcitinaman ci oma kiskiyitamiwin?**

- Kiwekimăkan awa năntaw kaki totaht, kih wakomăkan, ka wetapimat ahpo ka pamihat, ahpo keya e-kitapamat, kekihk ahpo oyasowewinihk, ekwa ekă ike nătamasot (e.g., tăskoc e-akosit, ekă pikwesi ike isi waskawet ahpo ci awasis); ahpo mena
- Keya e-pamihimat anihi ka kih pamihat tăskoc ike nakatasket akace ekă ike nepawestamasot.

# Tansoma ka kih is Kacitinen Kiskiyitamiwin?

Moya semāk ka meykawin kekwāy ka kiskiyitahkwahk anohci kiphawakan. Keya ahpo kotak awayak ka masinahot kita nepawestamāsk piko ta mekeyin masinahamātowin e-nitaweyitaman oma e-nohte kiskeyitaman kekwāy, ewakonima isiyikātew e-masinahaman kih wehowin”. Kespın awa omisiho nawac mistahi mena neswaskiy ka kipahikāsot, ka kih kacitināwak oki CSC ahpo PBC ka nitotamayin oma e-nohte kiskiyitaman. Ispih masinahamani kih wehiwin nāntaw peyak oki, ekosi napo ka kih itsahamakwak kekwāy ka nohte kiskihnihtaman.

Kespın awa tipahaskānihk ohci e-kipahikāsot (i.e. tāsokc nohtaw neso askiy ta kipahikāsot), keya ka kih kacitināwak oki ka wihcihācik ka pacitotāmiht tipahaskānihk ka picik ahpo PBC ka meyiskwaw kekwāy ka nohte kiskiyitaman. Ote Ontario ekwa Quebec ka nohte kacitināwak oki tipahaskānihk ka ohci ma mawapicik.

Oma ka masinahosowin CSC ahpo PBC, ohi kekwāya ka meyikawin:

- Ana omisiho oweyowin;
- Anima ka kih itākamikisit awa omisiho ka kih ohci kipahikāsot ekwa mena anima oyasowewikamihk ka kih kesasowatiht
- Ispih ka maci kipahikāsot ekwa eyikohk kinwes; asci
- Kespin ci kitwam toyasowaniwk anihi eksikawa aciyaw ka pakitiniht.

Mena, weya e-masinahikasowin, ka kih meykawin oma ka nohte kiskiyitaman, kespin awa Commissioner ka nekānet oma CSC ahpo ka nistam apit PBC tapwetam kitinac ekā nāntaw ka isi pacitoat aw aka ki kipahikāsot om aka nohte katat kekwāy ekā katac ka kiskiyitakwaniyik ayahk esa pakitinikateki kekwāy ka kiskihyitahkwak:

- Ka kipahot awa e-itatwato piponet;
- Kesihyikatek ekwa ita e-ayak kipahotowikamik ita kasowasot;
- Kespina ka kih acitsahot, kekwāy ohci ka acitsahot ekwa men aka isiyikāte anima kipahotowikamihk it ikayāt, asci neyac ta kiskeyitamohiht, oma ke ispayiki, ita nawac ekā mistahi ka kitāpamiht;
- Ka wihtamaskik oki CSC ka wayāwihtahiht Kānata ohci kicih anima *Immigration and Refugee Protection Act* oyasowewin kiseyikatek emwayes kesi kipahikāsot;
- Tānsi e-itahkamikisit awa kipahakan ahpo eke peci itākamikisit;
- Ahpo kespina nāntaw ke isi kostatahkamikisew;
- Kesikāwa ka wi nitotaht ka acimot ohci oma PBC ka kihtwām oyasowāniwik;
- Kespina ahpo awa omisiho kipahikasew ahpo namwāc ekwa kekwāy kicih;
- Māhti ci ke kakwe kocihtaw ta pihtaht PBC ka oyasowecik ekwa tānsi kakah ispayik; mena

- Kekwāy kicīh ekā ka pakitiniht ka ayamit oma kicīh section 140(1) anima *Corrections and Conditional Release Act* (CCRA) oyasowewin, kespīn ke nitotamāw.

Oma kekwāy ka kiskihyitaman **ka kih** meykawīn awa kicīh Ka Nekānapit ota PBC<sup>1</sup> ahpo awa otoyasowew ota kicīh CSC<sup>2</sup>:

- Anima kesikāw, kespīn kekwāy, ispih awa kipahakan ka pakitiniht aciyaw ka sipwetet, ka pakitiniht ka atosket, ka pakitihit ka kitāpamiht ekosesi;
- Kotaka anihi kīhtiht ka totahk aciyaw pakitinici, atoskewi pakitinicih, ka kitāpamiht ka pakitiniht ahpo oyasowewinihk isi ka pakitiniht ekwa anima kekwāy ohci aciyaw ka pakitihit; mena
- Ita ka wi itohtet oma ka pakitiniht, atoskecih, kitapamicīh pakitinihcih, ahpo oyasowewin ohci, ekwa kespīn awa kipahakan ekota kisiwak ka ayāw ita aw aka kih pacitotahk westa e-ayat om aka pimotehot.

Ekwa oma ka kih kiskiyitaman meykaweyinih awa kicih Oyasowew ota CSC, ayis piko 14 newosap kesikāwa pamiwes awa ka pakitiniht, kespín ta kih ispayik. Mena, awa Oyasowew kicih CSC poko ka kacitinisk kespín kekwāy petos ka ispayin.

Kespín awa kipahakan acitsawaw ote isi tipahaskānihk ohci kipahotowikamik, keya ka kih meykawin anima tipahaskan ite ka itsahikasot.

E-masinahikāsowin eke pacitotākaweyin, ka kih māka ekatenen oma ka kiskihyitaman kekwāy pikwespih.

# **Kitayān oma pekiskwewin Kipahotowinihk ekwa Ka Pakitiniht Kipawākan**

CSC ekwa PBC weyawaw wihkotamwak kekwāy ka kiskihyitakwahk oma kicih ka astāsiyin ekwa mena tānsi awa e-itskakowin oma ka kih totakaweyin keya,

kih wahkomākanak mena aniki kitihawinhk ka ayācīk. Ka kih pacitotācīk aniki, pikwespih, ka kih wihtamwak kekwāy ka kih wecīhīkocīk anīhi kīcīh CSC ahpo PBC kitimiht. Ka kih kakwecekemon ta apeyin awa kipawākan ka oyasowatiht tāskoc e-kitapahkeyin ascī ka kih ayamihtan anima kekwāy ka masinahīkatek PBC Board ekota kapičīk, ka witamiok, ka kih pekweyitaman/ahpo ka kih wanihat soniyaw (kitapacīkan mena ka pekonīkatek) ka itskakowin. Ka kih wapateyoskan oma ka wapacīkatek kih pekīskwewin, ka meyīcīk oki PBC kapičīk mekwac oma oyasowāniwīki. Ekwa e-masinahīkātek ewako pīko ka mekeyin. PBC ka nitaweyitamwak e-masinahīkāteyīk nīsto mitanaw kesīkāw 30 emwayes kespīn ekā katac ka itwestamacīkātek ekwa 45 nemitanaw neyananosap kesīkāw kespīn pōko ka itwestamacīkatek.

Ka kih nitotaman mena oma Victims Fund, ka itamihk ka pamīhtacīk oki Department of Justice Canada, ka wecīhīkaweyin ka itoteyin PBC koyasowāniwīk ana ka kih pacitotāsk. Māka pōko ka masinahīkasowin ota CSC ahpo PBC kecīkateki ta kācītinaman ewakoni. Oma Victims Fund ka icīkoātek mena ka wecīhīkowin awayak ka kih wecewīsk weya e-masinahīkasowin eke pacitotakaweyin ota oma PBC ka kih apīcīk.

## **Oma ka Pekiskweyin ka Wihtamawaw ci awa Kipawākan?**

Keya kicih kekwāy, tās̄koc ita ka wekiyin, kitakihtason ekwa ita ka kih isi kācitinikaweyin namoya ka wihtamawaw awa ka kih pacitotās̄k. Māka, oyasowewin itastew CSC asci PBC oki ki ta wihtamawacik ohi kipawākana kekwāy ka wi miskocikatek oma ka oyasowik, tās̄koc oma kekwāy ka wihtahk awa ka kih pacitotāht, ahpo pakahn ewako.

## **Tānsi oma CSC e-itapacitahk Kekwāy ka Wihtaman?**

Kespin kih ki sakaskinatān Masinahikan oma Ka Pacitotakaweyin ispih ka oyasowāniwik, CSC ta kacitinamwak kotaka asci masinahikana owehowinihk kasteyiki awa ka oyasowātiht. Pikwespih oma ka oyasowatiht, e-masinahikatek anima pekiskwewin e-wihcikatekkekwāy ka kih pakitinen kita wecihikocik oki CSC ka oyasowecik. Ka pacitotāht awa kekwāy kicih ka pakitnikatek CSC oki mena wapahtamwak PBC ekwa e-apatahk ota:

- Ka oyasowāniwik oma e-ispihci ayatahki kipahotowikamikwa ka kiteyitakwak;

- Oma ka wihtamācīk PBC kespīn cī awa kipawākan ka kī pakitiniht aciyaw, tāskoc ka kiteyimiht ka wayāwet, ekwa tānsi ka totahk wayāweci;
- Ka oyasowāniwik māhti cī ka pakitiniht wayāwitimiht ka atosket; mena
- Oma ka ka kocīhiht awa kipawākan māhti cī kihtwām ka misihot ekwa ka kakeskimiht.

## **Tānsi PBC e-tapacitacik kekwāy ka meyacik?**

Kekwāy ka wihtamawacik oki PBC maywapatan e-nistotācīk sokeskakowin oma ka kih totākaweyin ekwa kespīn cī awa ka pacitotāsk kiskihitam ewakweyew ka kih totask. Oma ka kiskihytācīk ka wechīkwak PBC ta oyihtakīk māhti cī:

- Kihtwām ekosi ka a itākamīkisit kepin pakitinihci masinahikan ka pimotaht; ekwa mena
- Kotak kekwāy ka itastamaht nāntaw we isi astahiwechī ka itākamīkisit, wawes cī kisiwak ita e-ayayin ahpo kiwahkomākanak ekota pih wekīchī.

Ka meskwatastaniwik anima CVBR poko PBC ta wihtācīk tānsi oma ka wī isi kitapamacīk ohi kipawākana ketastamayit Long-Term Supervision Order ka icīkoātek oma ka kih masinahaman kitacimowin.

Awa CCRA asay kih pakitinew ohi Board kāpeyit ketastamawayit ohi kipawākana ka peyatakisiyit oma aceyaw ka peyako pakitinimiht, ahpo oyasowewinihk isi ka pakitinimiht. Tāskoc, oki Board kapticik ka kih itastamawewak ekā nāntaw ka isi kacitinisk awa ka pacitotāsk ka kakwe ayamihisk, mena ekā kisiwāk ka itotet ita ka wekiyin.

## **Ka Waweyestaman oma ka wi pakitiniht Kipawākan?**

onasowewikamikohk oyasowewinihk, kicih ka kanaweyita, ekwa ati masinaha tahtwāw ka kakwi ayamihisk;

- ka wihtaman e-isi pihtaman ita e-mayakamikisit awa ka kih pacitotāsk; ekwa
- nitotamā ekā ka westacihkāsk awa kawī-pakitiniht.

kekwāy ka kiskihitaman asay ka miskocikatek ekota (section 26 of the *Corrections and Conditional Release Act* (CCRA). Ewakoni Piskihc weyawaw wihtamawewak ka pacitotāmiht, otinamwak ka pacitotāmiht otayamiwiniyw, naskwewasihtwawak okakwecekemowiniyw ewako kicih ka misak kipahotowikamik ekwa ka pakitinihcik ka kitapamihcik, ekwa mena piko kekwāy ka nohte kiskihitaman oma kicih CSC's ka kahkwe wecihiwecik ekwa mena ka kawih nakiskātohcik ohi ka pekiskwatoyit kipahwākana asci anihi ka kih pacitowayit asici ka kiskinohtaniwecik ita oki kotakak owecihiwesak ka apicik referralstipahaskānihk mena kicih okimāwinihk. ## **Kipahotowikamikwa Kānata: Kanakiskātohk Piskihcikamik**

CSC wecihewak ka nakiskatoyit ohi ka pacitotakeyit ekwa anihi ka kih pacitotāmiht (VOM) ka wecihiwecik ita Restorative Opportunities (RO) kesihyikatek. VOM meyewak ohi ka pacitotāmiht ka pekiskwatayit anihi nāntaw ka kih totakoyit eyapacihacik ohi opekiskwestamakewa ka mamiskotamiyit oma ka isi totācic. Oma RO (kanakskatohk) ka kih

tawastamawewak ohi ka pacitotamihk ka acimisoyit, ka kakwecihkemoyit, ka nitawiyitamawacik ohi ka kih pacitotacocik, ekosi ka kipahakik oma ka kih ispahiyikocik. VOM oma e-pimitsahamik kesi nitawihytäkik oki ahpo ka masinahikecik, ka masinipahiyecik e-pekskwecik ekwa / ahpo kihciyaw e-nakiskatocik.

PBC ekota ayăwak oki Regional Communications Officers ka Simăkansewicik (RCOs) pa piskic ohi itawina ka kiskihitamohacik ka pacitotămiht kekwăy.
