Message/Executive Summary from the Chair

The Crime Prevention Committee is co-chaired by Chief Constable Ben Andersen and Dorothy Franklin. The year 2005-06 was full and productive for the Committee and its members. Contribution funding received from the National Crime Prevention Centre (NCPC) has again this year allowed the Committee to meet regularly, without having to seek funding from the CACP Safer and Healthier Canada Fund. Funding support allowed the Committee to attend the American Society of Criminology Conference in Toronto in conjunction with a Committee planning session. Moreover, funding from the National Crime Prevention Strategy enabled the Committee's most ambitious initiative, formation of a Coalition on Community Safety, Health and Well-being, to go ahead.

The Committee membership is stable, with vacancies filled promptly to ensure representation from all regions. Several CACP members have requested to join. Unfortunately the Committee cannot accept all who wish to join, because of the need to ensure equitable regional distribution, and to remain sufficiently modest in size so that our funding support from the NCPC is not at risk.

We enjoy active participation from members who bring federal, provincial, municipal and Aboriginal perspectives from the table, and from the non-governmental sector, which is a first for this Committee to our knowledge. Attendance at Committee meetings has been reliable, and individual Committee members have been active nationally and locally on behalf of the CACP.

The main focus of our work this year has been the Coalition on Community Safety, Health and Well-being. This is the most ambitious initiative of our Committee in memory, and will require a sustained commitment in the coming years and, we hope, beyond. A detailed report follows.

The Committee acknowledges with thanks the support of the Government of Canada in the form of resource persons from the NCPC at Public Safety Canada, and the RCMP. The Committee also thanks the CACP National Office, whose support to our Committee initiatives is instrumental in sustaining our level of activity.

Committee Mandate/Objective

The CACP, through its Crime Prevention Committee, is committed to providing leadership in adopting and promoting a comprehensive, inclusive approach addressing the root causes of crime and social disorder. The CACP supports positive social change to enhance the quality of life for our diverse communities.
