Message from the Chair:

The past 12 months have been particularly active for the Drug Abuse Committee from the communications perspective. With the federal government's launch of the NADS in October 2007, and numerous announcements about financial investments in programming and drug education, the committee was able to signal the CACP's support for the government's approach to some of the most difficult drug issues in Canada.

Consistent with the CACP Drug Policy, adopted at the AGM in Calgary, education and prevention initiatives were important over the last year including work with Health Canada on a toolkit for agencies. We are also continuing to advance standardized drug awareness training for police officers, as well as a new nation drug awareness initiative. This new project is a very exciting communications project in partnership with Health Canada that would see CACP at the forefront of a National Drug Awareness Campaign. Similar to a project that CACP supported in the 80s and 90s, this initiative has great potential to reach Canadians of all ages in order deliver clear and unequivocal messages about the harmful impact of drugs.

We are also very concerned about protocols being employed by agencies across the country in dealing with meth labs. Our committee will be working to facilitate the exchange of protocols and practices among agencies in order to ensure the safety of our staff and citizens. In the interim we will be encouraging agencies to devote special efforts to ensuring that have the appropriate policies in place regarding meth labs.

The most significant new priority that the committee will begin addressing is that of Drug Endangered Children. This issue is nothing new for most cops working the streets, but one that must be addressed aggressively at the national level. I look forward to bringing you an update on this issue, and I will be looking for your support on advancing this issue in the new future.

If the committee and the CACP are able to achieve anything, it is through the dedication of our members and so, in closing, I would like to thank all of the members of the committee past and present for their devotion to this work.
