2012 STRATEGIC PLAN – RESULTS

PROFESSIONALISM IN POLICING PROJECT

1. After three years of research, the Professionalism in Policing Project was completed.
2. The public launch occurred on February 14, 2012 and the Justice Institute of BC.
3. Once the 51 recommendations were made public, the following took place:
 - (a) Results were posted on the CACP website.
 - (b) Conducted 12 media interviews.
 - (c) Conducted 11 formal presentations including at the International Association of Chiefs of Police.
 - (d) The Committee worked with agencies that have begun to implement the recommendations (Ottawa, RCMP, etc).
 - (e) The Committee worked with agencies who have requested their own specific results from the survey (Waterloo, Peel, etc).
 - (f) Worked with Training Academies regarding recommendation implementation (Depot).
 - (g) Liaised with the Sheldon Chumir Foundation who have actively sponsored the project.
 - (h) Present final results at the 2012 CACP Annual Conference.
