We are pleased to report that the Law Amendments Committee has had an active and most productive year. Committee members have attended more parliamentary proceedings, participated in more consultations and undertaken more projects than in any other year in recent memory. An outline of the activities of the Committee together with the membership list is attached.

We would like to begin by acknowledging the hard work and special commitment of each of the members of the Committee who continue to take time away from their very busy schedules to participate directly in the activities of the Committee. In addition to representing the CACP in a most professional way, they are a credit to their own organizations.

The events of September 11, 2001 changed the legislative of the Government of Canada. In addition to Bill C-36, several Parliamentary Committees held hearings into various subjects related to security. While the issues associated with counter terrorism dominated the legislative agenda, other legislation, important to CACP members was also before Parliament, for example Bill 15, the Criminal Omibus Bill, and the Youth Criminal Justice Act. We are proud to confirm for the Board of Directors that the CACP has been well represented in all of their representations to Government.

The other achievement for the LAC was its most significant contribution and participation in the Terrorism Conference in January 2002. LAC members were part of the planning committee, facilitated and presented particular sessions at the Conference.
