### **Private Sector Liaison Committee**

The Committee is comprised of members from the following sectors: transportation, retail, energy, banking, security and investigative services, information services, policing, insurance, and other service industries.

### **Mandate:**

1. To be the national conduit that continuously strengthens the partnership between the private security sector, government agencies and the law enforcement community
2. To achieve mutual goals through the sharing of info and best practices to better protect the interests of our stakeholders.

### **Strategic Priorities/Objectives:**

#### OBJECTIVE:

Help Reduce Impact of Crime on the Economy, Business & Consumers

#### PRIORITIES:

1. PREVENTION - Education and Awareness

Collectively develop strategies to reduce the risks of crime and its harmful effects by intervening through education and awareness initiatives to; sensitize the Canadian public and key stakeholders on conditions where crime can emerge, promote community safety, and contribute to sustainable development of affected agencies.

2. INFORMATION- Collection, Sharing, and Analysis

Sharing of information, expertise, and best practices between the private sector, government, and law enforcement to identify criminal trends and sources of threats in order to equip agencies with information needed for effective mitigation of crime.

Shape strategic partnerships between law enforcement and private sector agencies working to influence private and public sector decision makers, by providing means to support investigations and prosecution of fraudulent activity across jurisdictional boundaries.

### **Significant Accomplishments 2012-2013:**

- Advanced the modernization of the Canadian Anti-Fraud (CAFC) Centre by addressing data requirements and working through issues and obstacles.
- Organized a conference with a focus on the exchange of information and best practices.
- Progress on implementation of the PSLC recognition program.
- Updated PSLC page on CACP website.

### **Initiatives Planned 2013/2014:**

- Host a meeting in North Bay to engage PSLC committee members in the CAFC in order to gain better understanding of how the CAFC operates.
- Pursue the development of a “Proof of concept” with private sector and law enforcement data. As a pilot, the data will be analyzed and trends, patterns or various networks will be identified which will allow law enforcement and private sector alike to take appropriate action based on the nature of the information revealed.
- Host a conference - Educational Forum Making a Difference: The Increasing Role of the Private Sector in Public Safety”. On October 2013. Target audience: 150.
- Fully implement the PSLC recognition award program.
