RECOMMENDATION

CONCLUSION

The crime statistics for the month of July 2013 reflect a decrease in Crimes Against the Person of (-10.0%) compared to July 2012, while Crimes Against Property show an (-11.5%) decrease compared to July 2012. Crimes Against the Person and Crimes Against Property show a combined year-to-date reduction of (-11.2%).

BACKGROUND

Each month, reports providing statistics for the City of Regina are presented to the Board for their review and information. This report will provide statistics for the month of July 2013. The Communications Centre statistics are included showing the total calls for service.

DISCUSSION

Crimes Against Property reflect a decrease of (-751) reported incidents over 2012, for an overall year-to-date decrease of (-11.5%). We have seen a decrease of (-327) reported incidents of Theft Under \$5000 for an (-11.6%) decrease. There are (-197) fewer reported incidents of Mischief / Wilful Damage for a (-12.5%) decrease.

Thefts of Auto rates have decreased by (-165) incidents for an overall decrease of (-25.9%) in our year-to-date statistics. The Regina Police Service in conjunction with its partners in the Stolen Auto Strategy continues to pay constant attention to this issue.

Crimes Against the Person reflect a year-to-date decrease of (-169) fewer incidents over July 2013 for a (-10%) decrease. There were 22 reported Robberies in July for a year-to-date decrease of (-22) incidents or a decrease of (-14.6%).

Overall the Regina Police Service has received (-920) fewer reported incidents of Crimes Against the Person and Crimes Against Property combined in 2013 over 2012 incidents for an (-11.2%) decrease.

There were a total of 6136 dispatched Calls for Service in July for a year-to-date reduction of (-0.6%) and Alarm Calls for Service show a year-to-date decrease of (-1.8%).

CONCLUSION

Regina's total reported crime at mid-year 2013 was at its lowest point in the past ten years. Both Crimes Against the Person and Crimes Against Property were ten-year lows. Crime types that were ten-year lows included Assault, Robbery, Criminal Harassment / Stalking, Motor Vehicle Theft, Theft, Break and Enter, and Mischief. Traffic offences (Criminal Code and Highway Traffic Act offences) and drug offences were at ten-year highs.

BACKGROUND

Twice each year, once at mid-year and once at year-end, the Regina Police Service provides an analysis of police-reported crime in Regina over the previous ten-year period. This report compares data compiled from January 1 to June 30 for the period of 2004 through 2013.

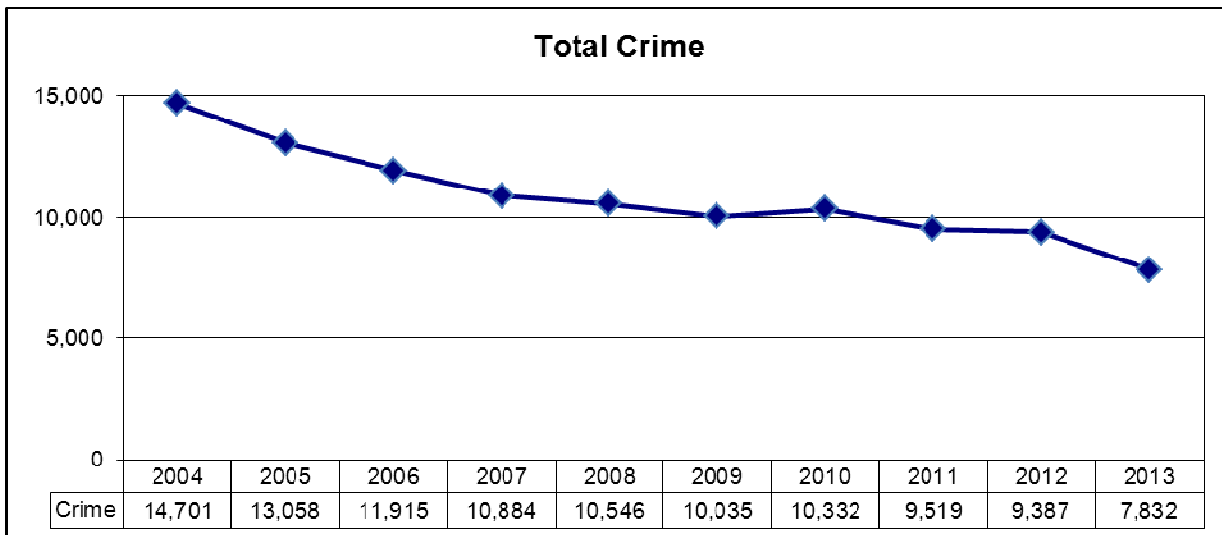
Measuring crime statistics¹ and their changes over time is effective for identifying trends. The Regina Police Service gathers data in the same manner each year, allowing for reliable analyses of crime within the city over time.

DISCUSSION

There were 16.6% fewer reported Total Crimes² than at mid-year 2012 and 46.7% fewer than at mid-year 2004. In the first six months of 2004, the number of reported crimes in the City of Regina was 14,701 compared to 7,832 in 2013. This is a reduction of over 1,500 incidents compared to the year before and almost seven thousand compared to a decade earlier.

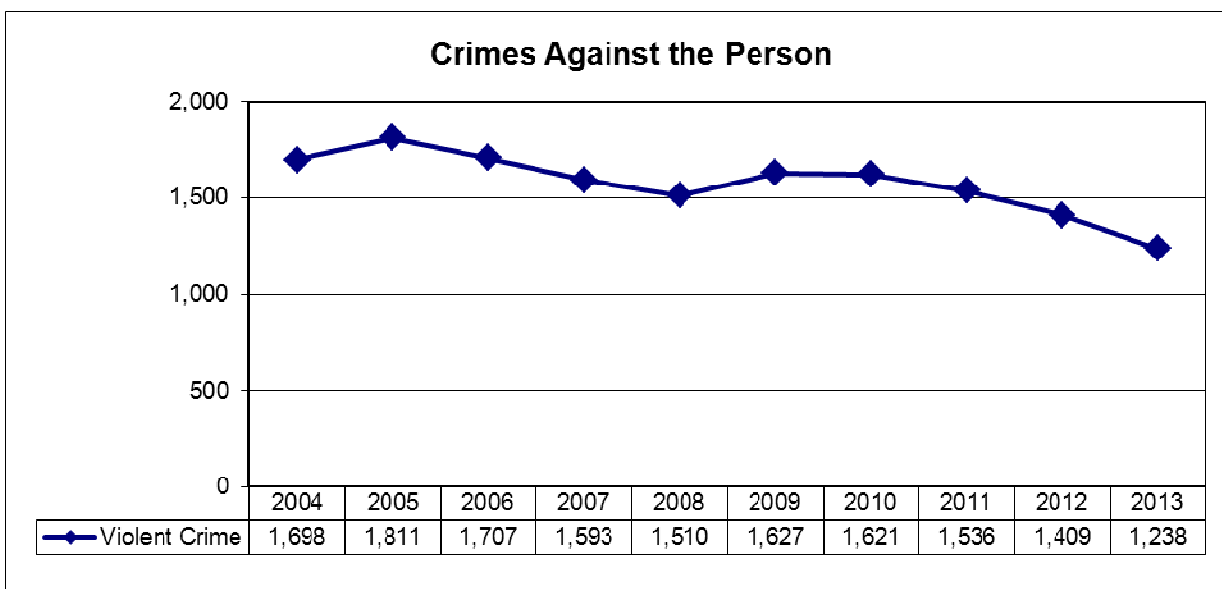
¹ Absolute crime counts, rather than crime rates or crime severity, are the basis of this analysis. These statistics are not intended for comparison with other jurisdictions that may use different methodologies or have different reporting criteria.

² Included in Total Crime are Crimes Against the Person, Crimes Against Property, and Other Criminal Code violations. Traffic and drug violations are not included.



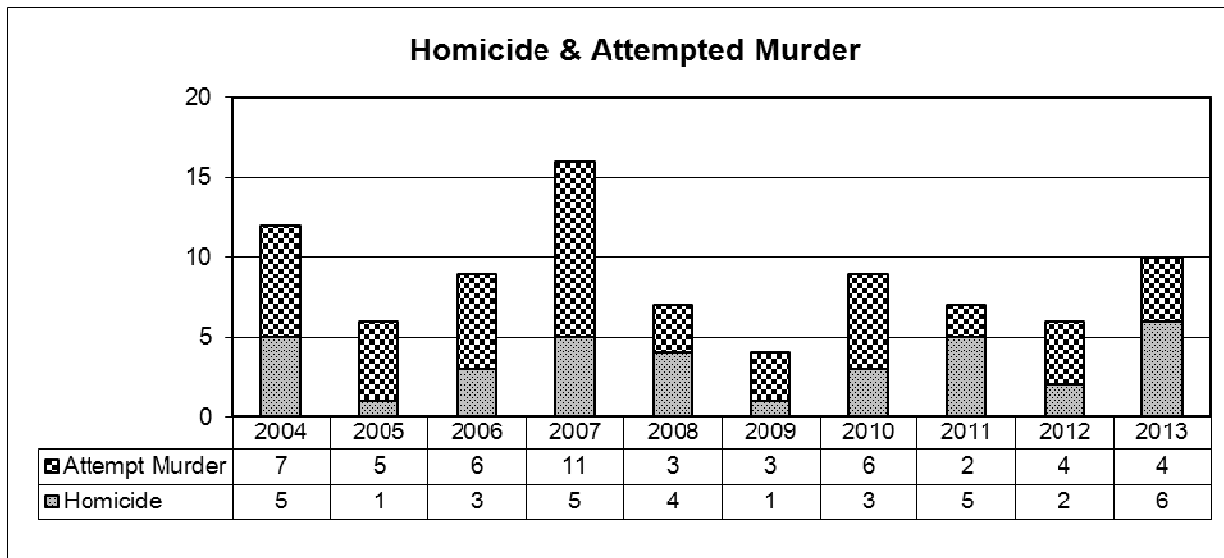
Crimes Against the Person

There were 12.1% fewer reported Crimes Against the Person than at mid-year 2012 and 27.1% fewer than at mid-year 2004.

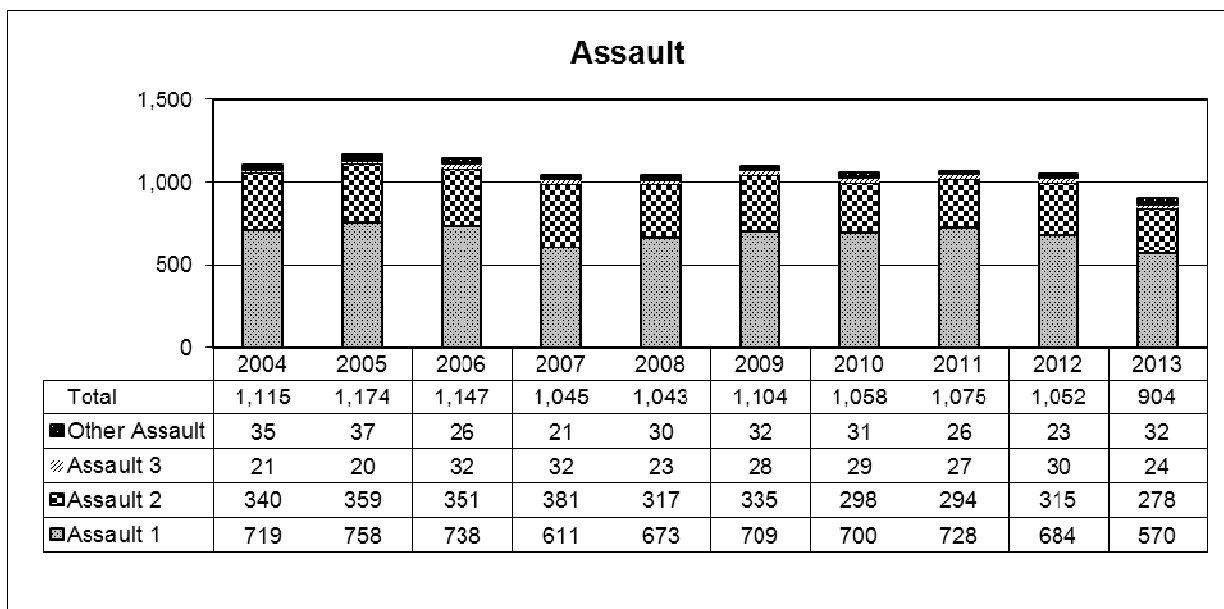


The six Homicides at mid-year 2013 were more than the mean average for the mid-point for the ten-year period ($\bar{x} = 3.5$). The four Attempted Murders were fewer than the ten-year mean average ($\bar{x} = 5.1$).³

³ Percentage changes will not be utilized in this report when discussing crime types with relatively low counts. Instead, comparisons to the ten-year mean average (\bar{x}) will be utilized when appropriate.

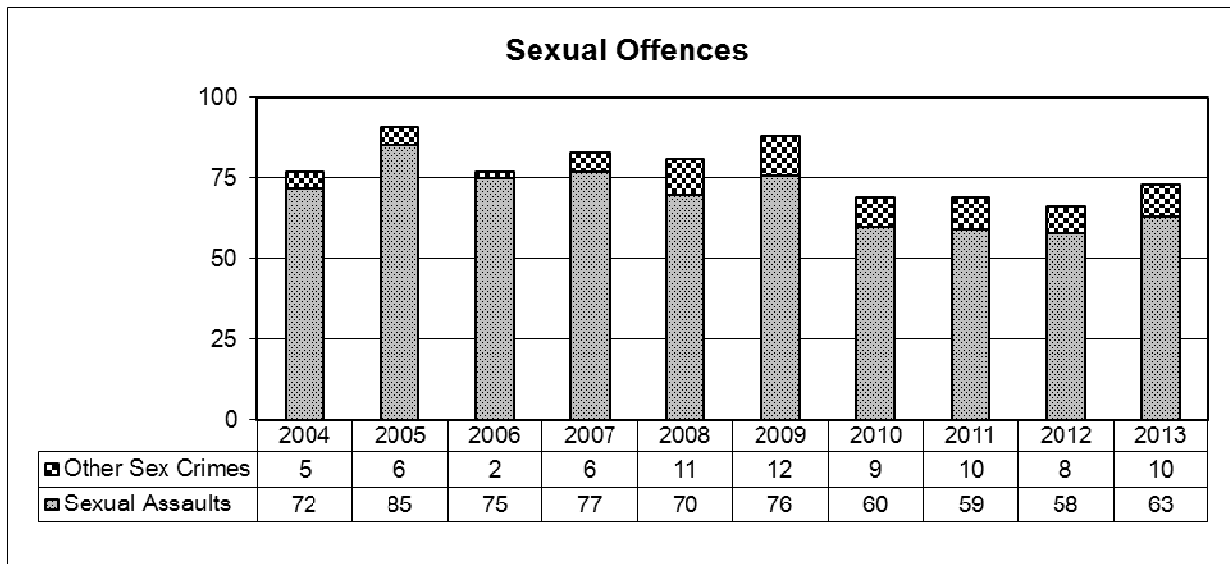


The total Assaults reported at mid-year 2013 were a ten-year low, with 14.1% fewer than at mid-year 2012 and 18.9% fewer than at mid-year 2004. Almost two-thirds of the total Assaults in the first half of 2013 were Common Assaults, with Assaults with a Weapon or Causing Bodily Harm comprising most of the remaining third. Aggravated Assaults accounted for 2.7% of the total Assault count.

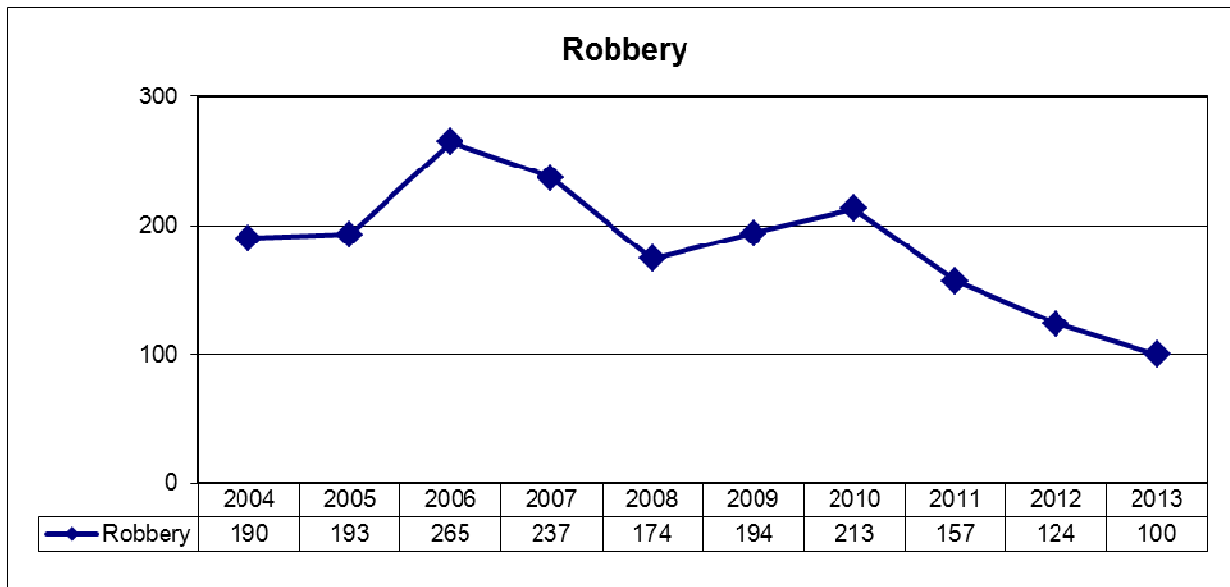


The sixty-three Sexual Assaults at mid-year 2013 were lower than the ten-year average ($\bar{x} = 69.5$). The ten Other Sex Crimes⁴ were higher than the ten-year mean average ($\bar{x} = 7.9$).

⁴ The crime category Other Sexual Crime includes (though this is not an exhaustive list): Sexual Interference, Invitation to Sexual Touching, Luring a Child via a Computer, and Voyeurism.

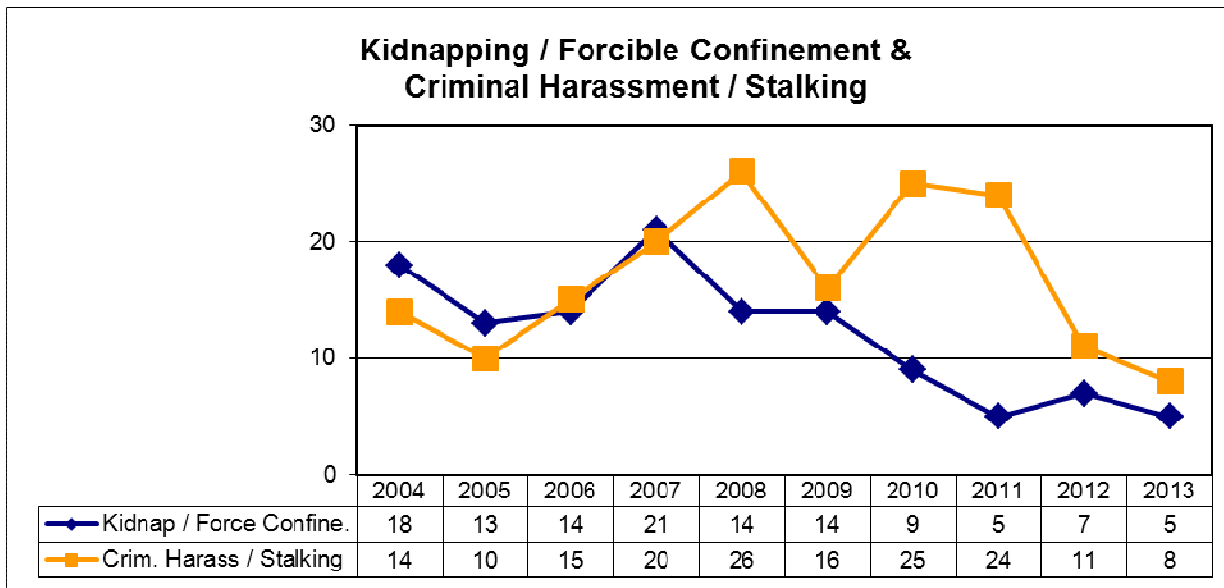


Robbery at mid-year 2013 was a ten-year low, with 19.4% fewer reported than at mid-year 2012 and 47.4% fewer than at mid-year 2004. Developing a comprehensive strategy to reduce street robbery is an initiative in the Regina Police Service Strategic Plan. To this end, a new Regina Police Service Robbery strategy was implemented on January 13th of this year.



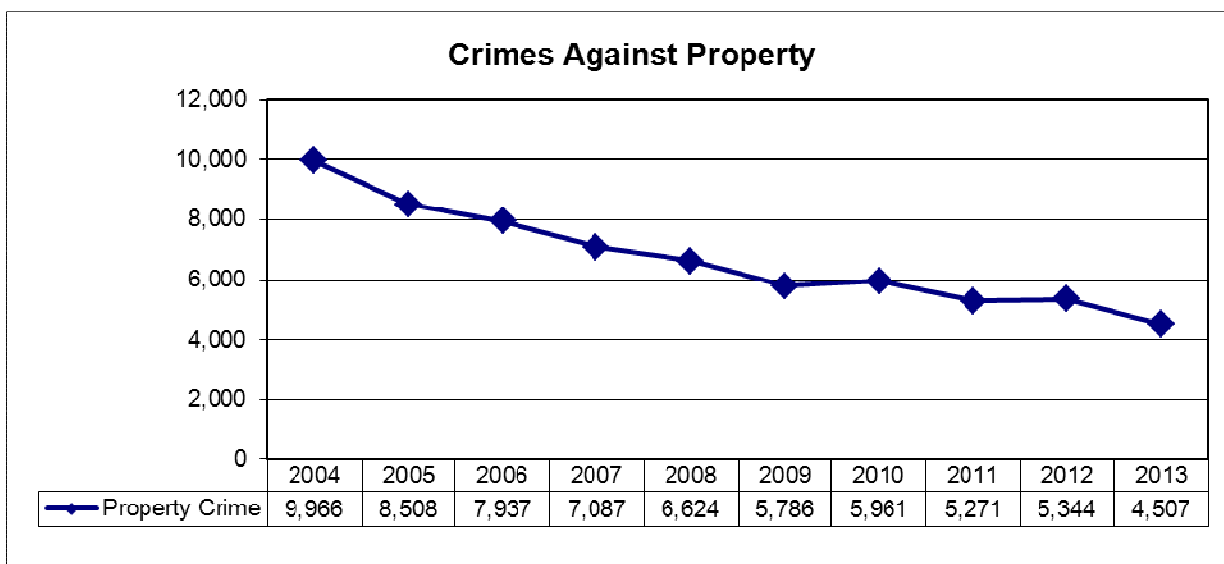
The five reported occurrences of Kidnapping / Forcible Confinement at mid-year 2013 was lower than the ten-year mean average ($\bar{x} = 12.0$).

The eight reported Criminal Harassment / Stalking occurrences at mid-year 2013 was lower than the ten-year mean average ($\bar{x} = 16.9$).

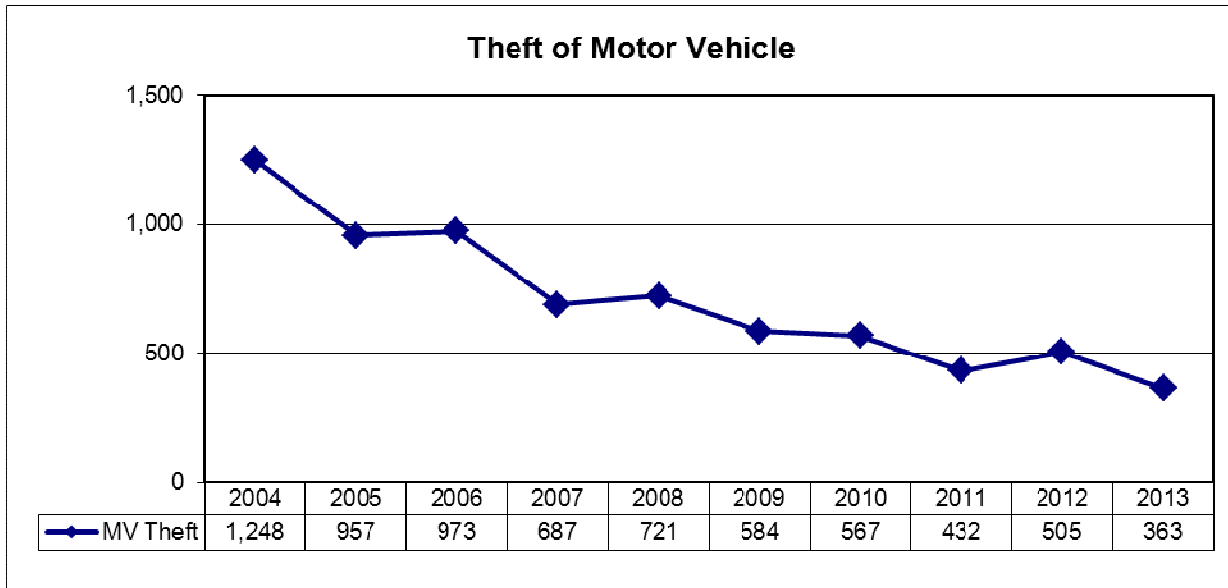


Crimes Against Property

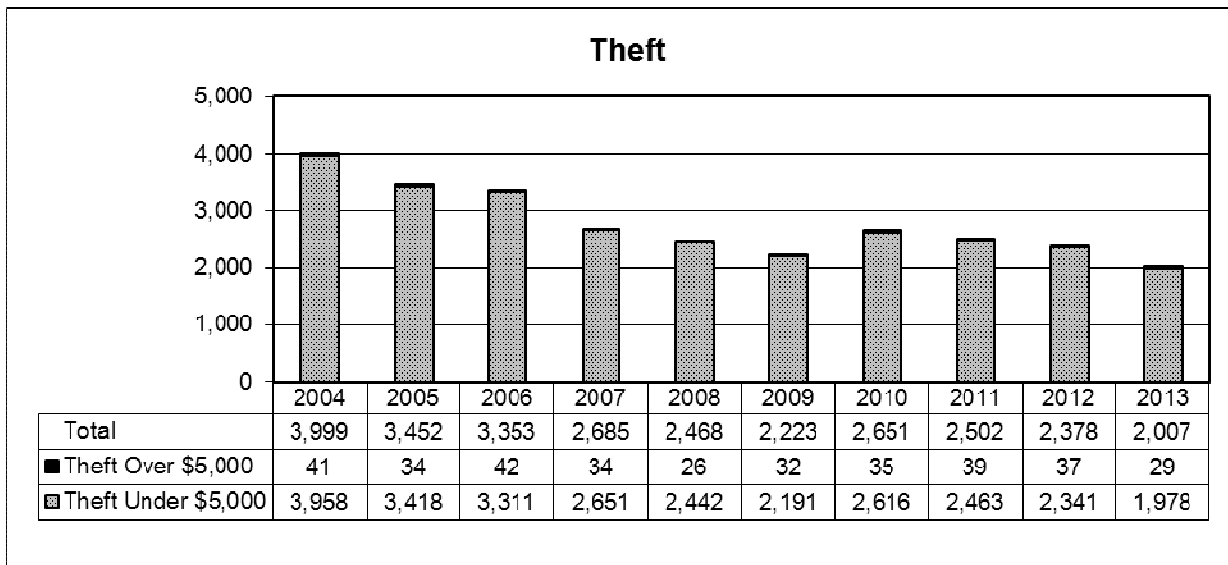
There were 15.7% fewer reported Crimes Against Property than at mid-year 2012 and 54.8% fewer than at mid-year 2004.



The number of Theft of Motor Vehicle occurrences in the first half of 2013 was a ten-year low, with 28.1% fewer Motor Vehicles Thefts than at mid-year 2012 and 70.9% fewer than at mid-year 2004. Contributing factors to this decrease include the Regina Police Auto Theft Strategy, as well as improved security features in newer vehicles.

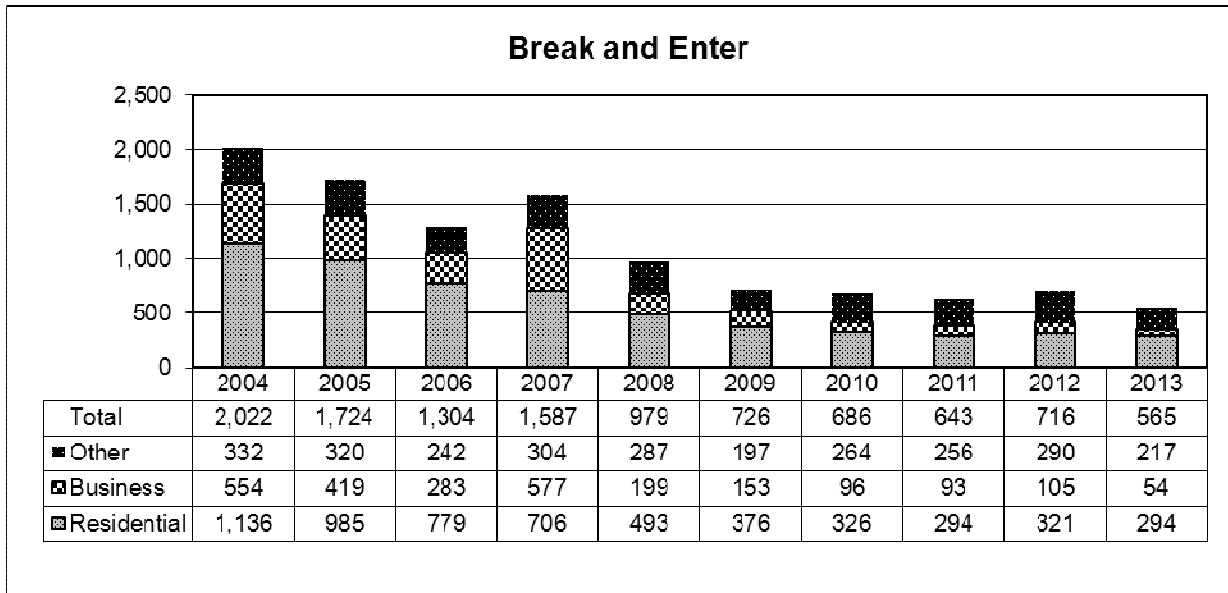


Theft⁵ comprised over one-quarter of Total Crime in Regina in the first half of 2013. Like Theft of Motor Vehicle, Theft was at a ten-year low with 15.6% fewer than at mid-year 2012 and 49.8% fewer than at mid-year 2004. Less than 2% of Thefts involved property valued at more than \$5,000. Over one-third of the reported Theft offences were Theft from Auto.

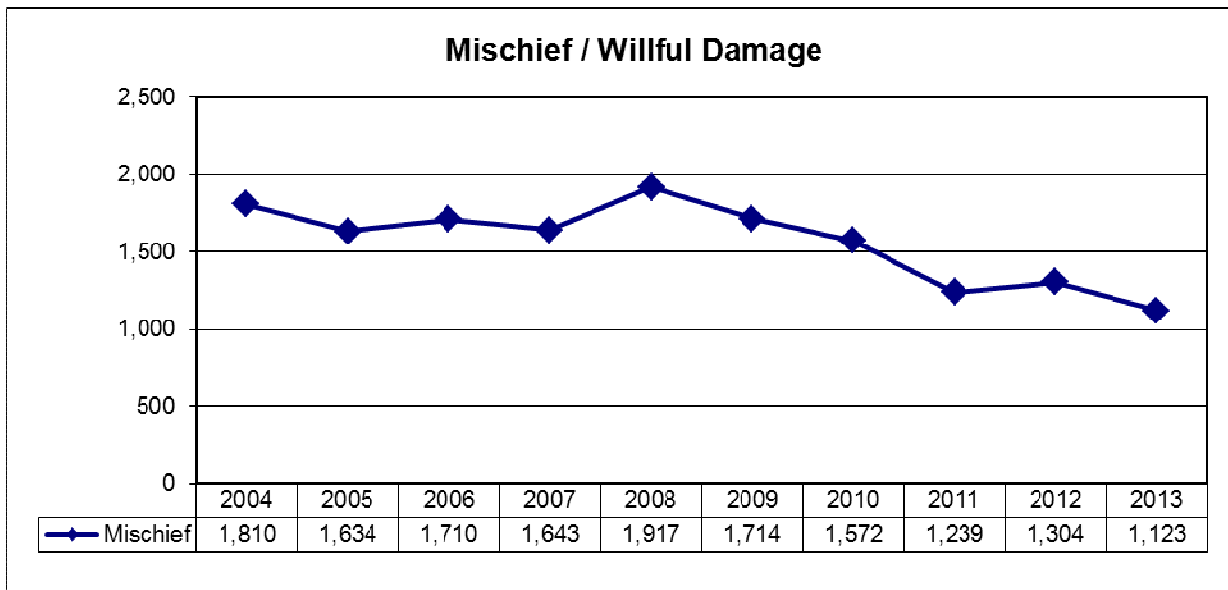


Break and Enter occurrences were also a ten-year low. There were 21.1% fewer reported Break and Enters than at mid-year 2012 and 72.1% fewer than at mid-year 2004. A reduction strategy, modeled after the Regina Auto Theft Strategy, was implemented following the increase in Break and Enters from 2006 to 2007. Preventative measures taken by Regina residents, such as home security systems, may also partly explain the ten-year reduction.

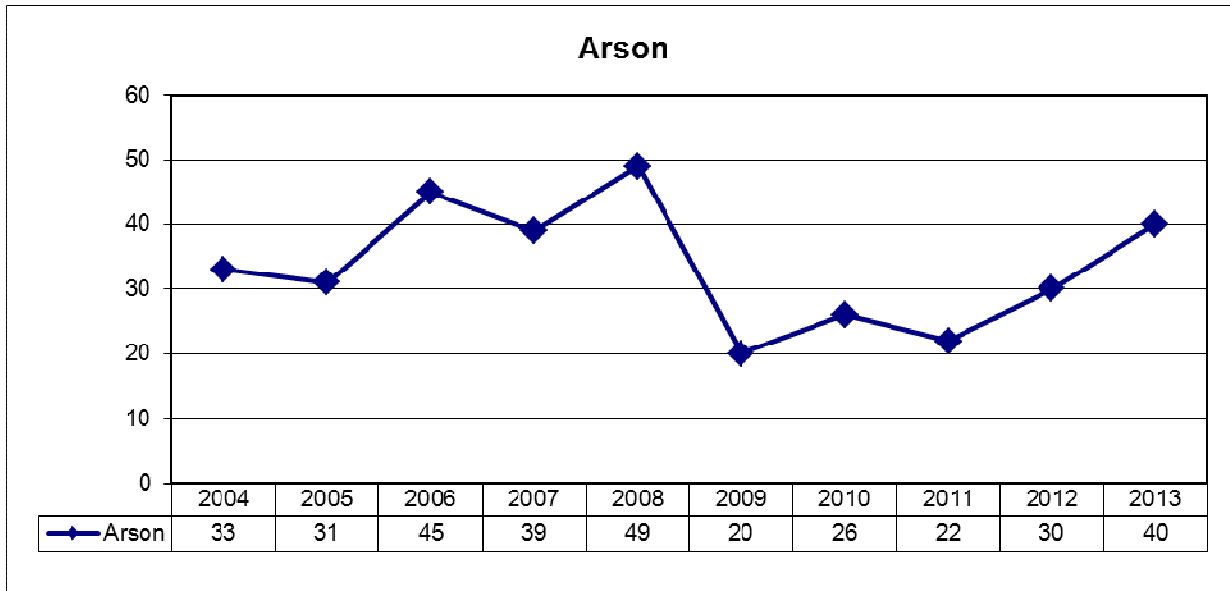
⁵ The category Theft includes: theft, shoplifting, and theft from motor vehicle. The category does not include theft of motor vehicle.



Mischief / Willful Damage at mid-year 2013 were also a ten-year low, with 13.9% fewer reported than at mid-year 2012 and 38.0% fewer than at mid-year 2004. The City of Regina and the Regina Police Service encourage public reporting of graffiti, a form of Mischief. The Regina Police Service also implemented a Graffiti Coordinator position in 2011 to increase investigative capacity. Of the reported Mischief by mid-year 2013, 15.9% were recorded as being occurrences of graffiti.

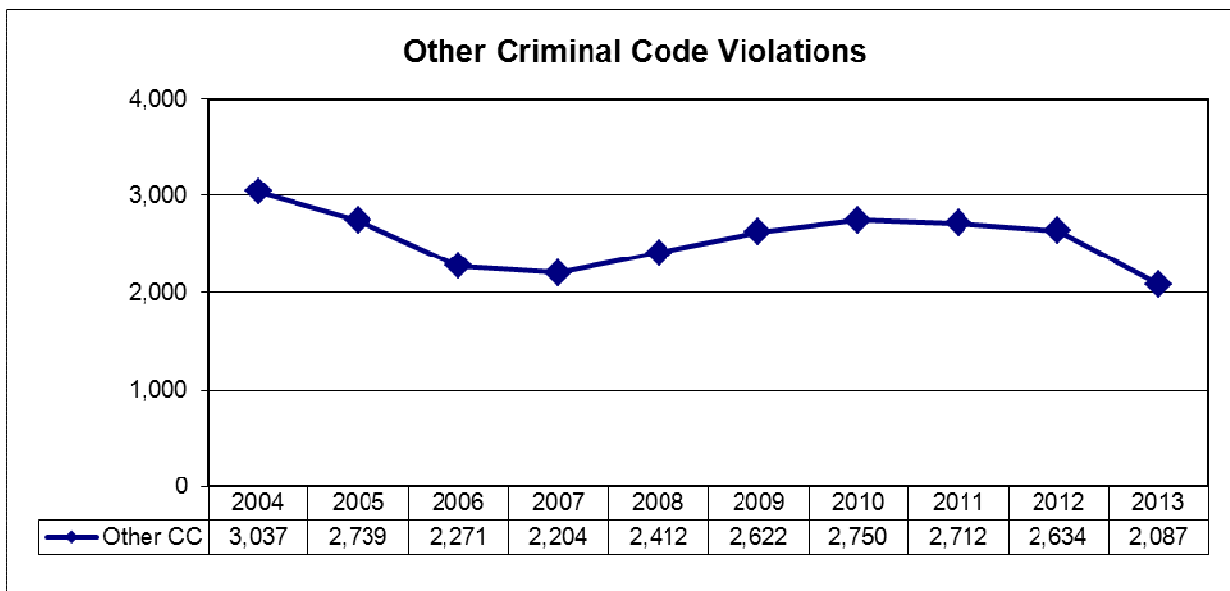


The forty reported Arson incidents at mid-year 2013 was higher than the ten-year mean average ($\bar{x} = 33.5$).



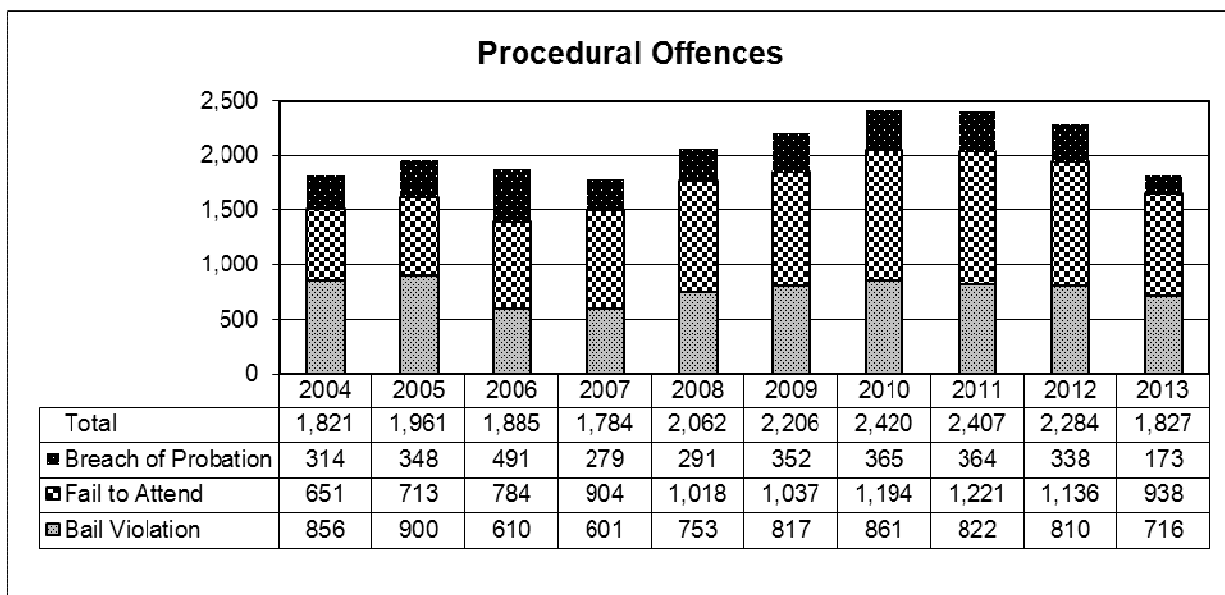
Other Criminal Code Violations

There were 20.8% fewer Other Criminal Code violations⁶ than at mid-year 2012 and 31.3% fewer than at mid-year 2004. Some reports falling under Other Criminal Code violations – such as procedural (or administration of justice) offences and prostitution charges – are partially generated through police initiatives and projects.

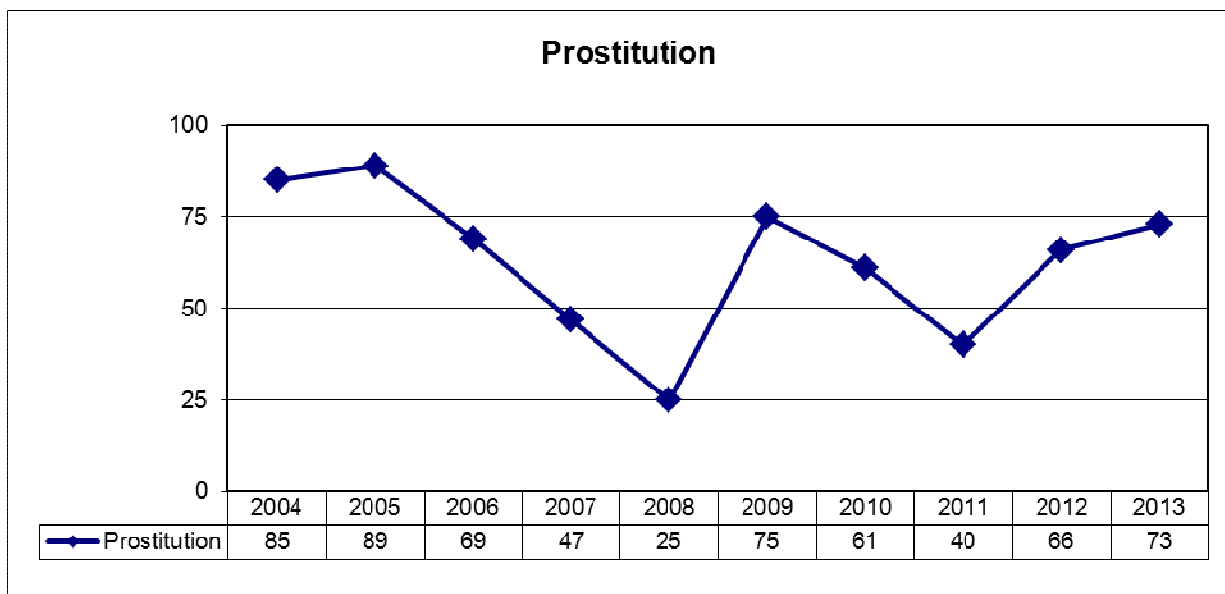


⁶ The crime category Other Criminal Code Violations includes: procedural violations, offensive weapons violations, prostitution, counterfeiting currency, and gaming and betting.

There were 20.0% fewer Procedural Offences than at mid-year 2012 but virtually the same number as at mid-year 2004. Procedural Offences make up a large portion of Other Criminal Code violations. Breach of Probation, Fail to Attend Court, and Bail Violations combined to account for 87.5% of all Other Criminal Code violations in the first half of 2013.

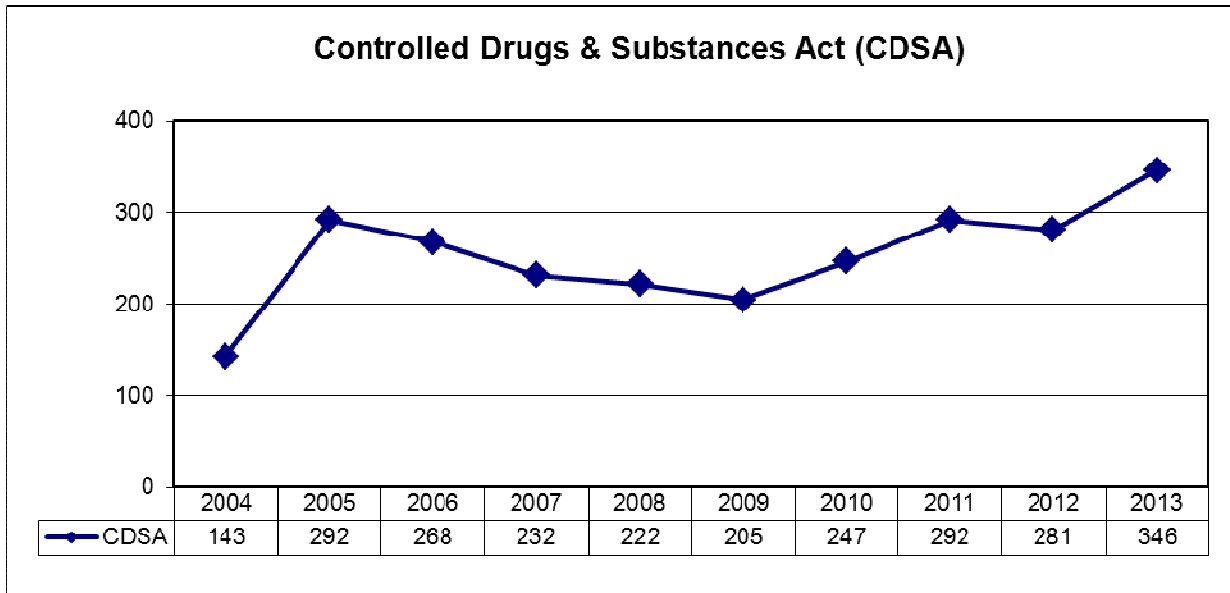


The seventy-three occurrences of Prostitution at mid-year 2013 were comparable to the ten-year mean average ($\bar{x} = 63.0$).

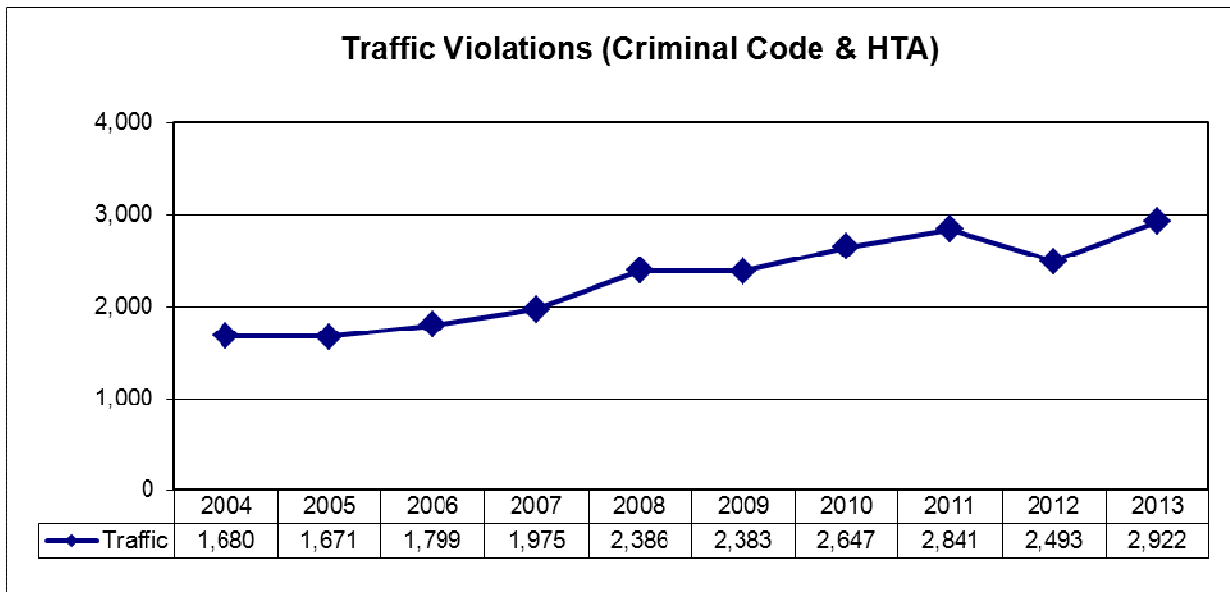


Controlled Drugs & Substances Act (CDSA) and Traffic Violations

There were 23.1% more CDSA occurrences than at mid-year 2012 and 142.0% more than at mid-year 2004. The increase in CDSA occurrences from 2004 to 2005 was related to the creation of a Special Enforcement Team (SET) and, shortly after, the Combined Forces Special Enforcement Unit (CFSEU), as well as organizational restructuring in the Regina Police Service's Criminal Investigation Division (CID).

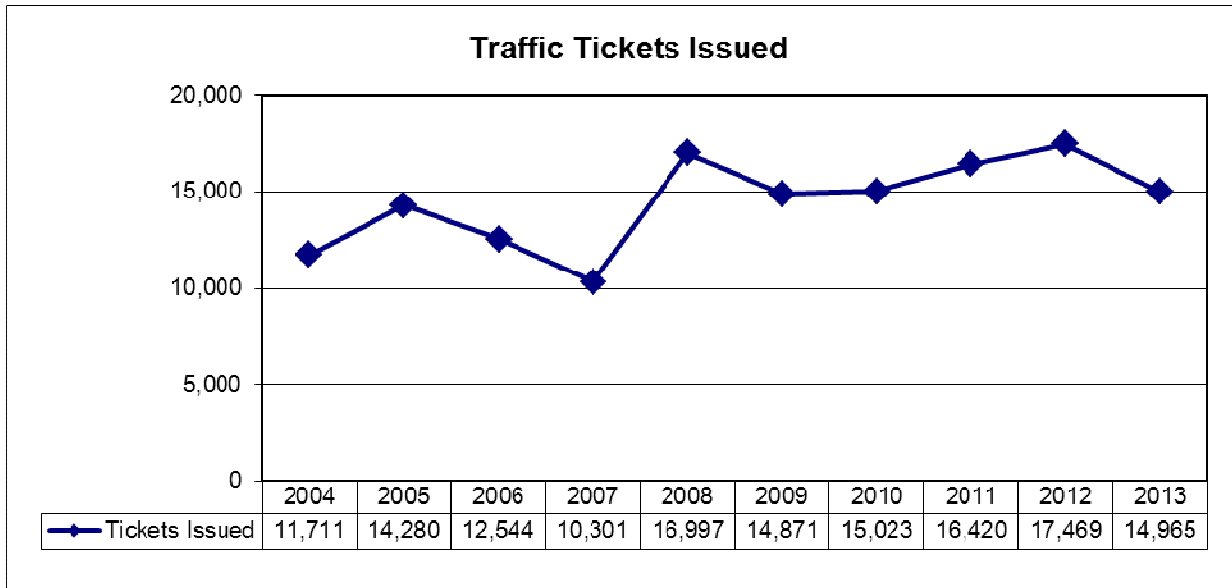


Traffic Violations, including offences from both the Criminal Code and the provincial Highway Traffic Act, increased by 17.2% compared to mid-year 2012 and by 73.9% compared to mid-year 2004. The number of Traffic Violations is partially generated through traffic initiatives and projects. Report Impaired Drivers (RID) and Enforcement Overdrive are two examples of collaborative programs that address impaired driving.



There were 14.3% fewer traffic tickets issued⁷ than at mid-year 2012 but 27.8% more than at mid-year 2004.

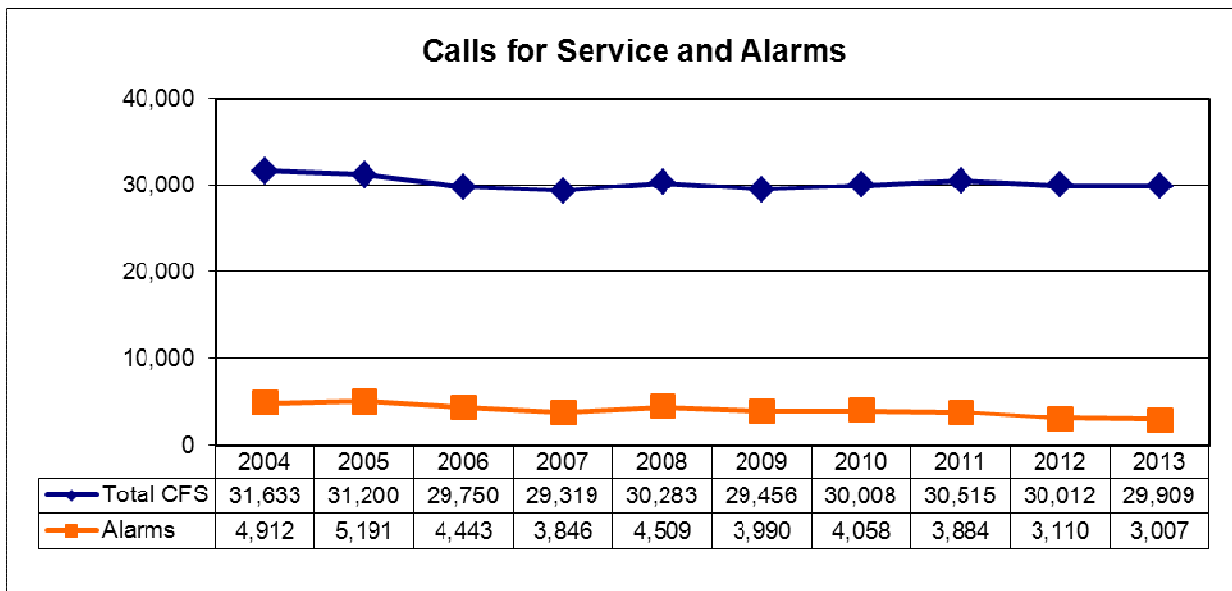

Calls for Service

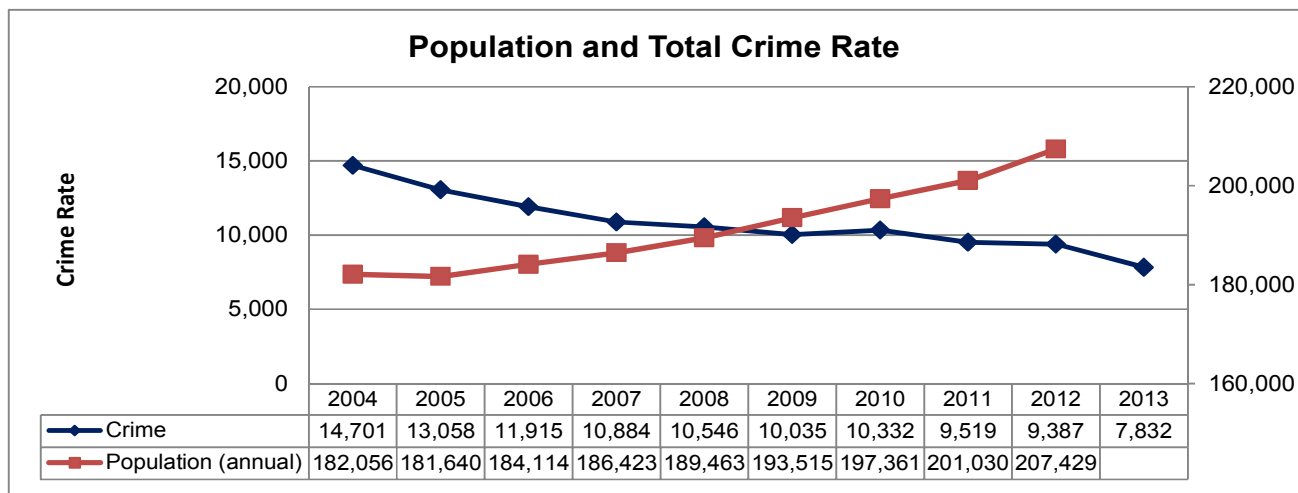
There were 0.3% fewer Calls for Service than at mid-year 2012 and 5.5% fewer than at mid-year 2004. Total Calls for Service have been relatively consistent over the ten-year period.

There were 3.3% fewer Alarm calls than at mid-year 2012 and 38.8% fewer than in 2004. Legislation regarding responsible alarm use was brought into force after the peak in 2005.



SUMMARY

Despite the expansion and population growth that Regina has experienced in recent years, crime in the city continues to decline. Over the last decade there has been a 46.7% reduction in crime, despite an increase of 13.9% in the population over the last nine years⁸.



Furthermore, both Crimes Against the Person and Crimes Against Property at mid-year 2013 were ten-year lows. Counts for drug and traffic offences were at ten-year highs, though the counts in these categories are for the most part enforcement driven.

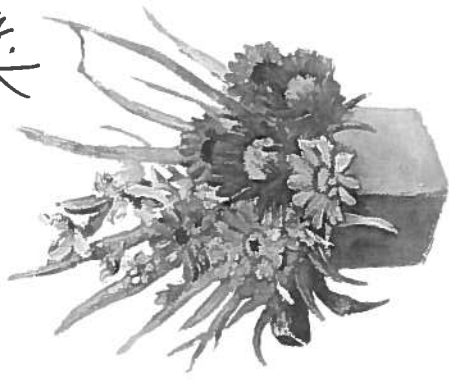

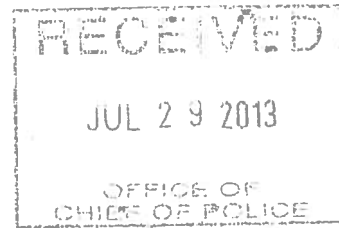

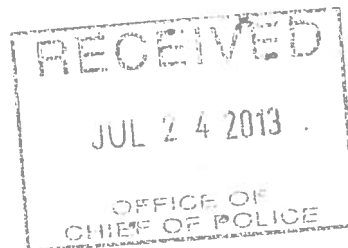

The financial results are not final just yet but we estimate we raised over \$46,000 for Pediatric Care at Regina's two hospitals through the Hospitals of Regina Foundation and more than \$6,000 for the Raise a Reader Foundation for literacy programs in Southern Saskatchewan.

On behalf of all the members of CPC Regina Centre I want to thank you for your generous support of this year's Plywood Cup and we hope we can count on you again for next year.

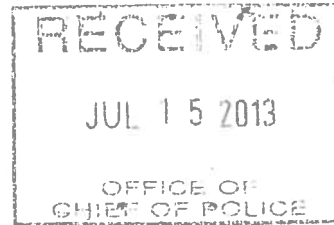

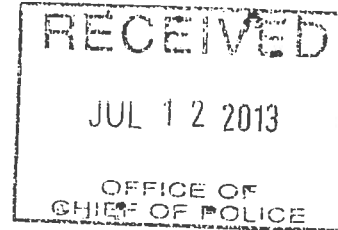
