INTRODUCTION

This collection of tables is a working document developed by Police and Security Branch, Ministry of the Solicitor General, during 1981 - 1982 in connection with the Federal Law Enforcement Under Review Project. It provides, in compact and accessible form, a portrait of the 157 Federal Statutes which include provision for one or more of the following peace officer powers:

- entry;
- search;
- seizure;
- detention;
- arrest with warrant;
- arrest without warrant; and/or
- the power of production of documents and the powers of a commissioner under the Inquiries Act.

For each of these Statutes, the following information is provided:

- name of the Statute and Responsible Minister or Ministers;
- powers conferred;
- individuals or bodies on whom the powers are conferred;
- RCMP agreements pertaining to the statute's enforcement (existing as of 1981);
- the penalties provided for under each statute; and
- the administrative and/or judicial processes appropriate to their prosecution.

STATUS

These tables provide a concise summary of Federal departments involved in law enforcement, the statutes for which they are responsible, the powers of their enforcement agents, and the content of enforcement agreements with the RCMP. They are intended primarily for use in policy analysis and development and, secondarily, to provide guidance for more detailed research. The information included has not, except in exceptional cases as noted, been confirmed with departments responsible for administering the statutes summarized. The contents of the tables should not, therefore, be relied upon conclusively as to current practice.

LIMITATIONS

No reference is made to the section or sections which provide for the powers except in those cases where the powers are conferred by regulation. The body of regulations is so immense (i.e.: regulations under the Canada Labour Code alone encompass more than 30 chapters) that such references were considered essential. The 1978 Consolidation of Regulations was used except in the case of the regulations under the Penitentiary Act.



The tables do not describe the enforcement of the statutes or regulations (i.e. number of cases, person-years, budgets, physical facilities, information centres or training), nor do they include the approximately 140 Federal statutes which describe offences and provide penalties but which have no provisions for peace officer powers, the power of production of documents or the powers of a commissioner under the Inquiries Act.

Where section 115 of the Criminal Code ("disobeying a statute") applies to the Acts and/or regulations under these Acts, it is not indicated on the tables in order to avoid considerable repetition. It is to be inferred that, where no specific offences or penalties are provided, section 115 of the Code would apply in the case of every one who willfully does anything forbidden in an Act of Parliament or who willfully omits to do anything that the Act requires to be done.

The tables have been distributed to several departments and agencies having relevant policy concerns. In addition to the Secretariat of the Ministry of the Solicitor General, copies have been provided to the RCMP, Correctional Services Canada, the Security Intelligence Transitional Group, the Department of Justice, the National Law Reform Commission, the Privy Council Office, the Ministry of State for Social Development and the Treasury Board Secretariat.
